Every six (6) years, the business must complete a full Recertification to maintain RTD SBE Certification. Failure to submit the required documents by the firm's anniversary may result in decertification and removal from RTD's SBE Directory. If there are any changes in the firm's ownership, control, legal structure, work performed, scope of services, or contact information, you must notify the Small Business Opportunity Office in writing immediately.

RTD also reserves the right to request additional information and/or to conduct an on-site visit or a more thorough review anytime during the term of this certification period. RTD reserves the right to withdraw, revoke,
