The City and County of Denver's Division of Small Business Opportunity (DSBO) is pleased to inform you that Aggregate Logistics, LLC is now certified as a Disadvantaged Business Enterprise (DBE) pursuant to the US Department of Transportation (USDOT) Code of Federal Regulation (CFR) Title 49 Part 26. Your firm, and the types of work you have been certified to perform, will be listed on the Colorado Unified Certification Program's (UCP) on-line directory at www.coloradodbe.org.

Aggregate Logistics, LLC is eligible to participate as a DBE on USDOT's financially-assisted projects in Colorado in the following NAICS Codes:

NAICS 484220: GRAVEL HAULING, LOCAL NAICS 484220: SAND HAULING, LOCAL NAICS 484220: TOP-SOIL HAULING, LOCAL

It is your responsibility to make sure the NAICS codes you are certified in are kept up to date. If you wish to become certified in an additional type of work, you must submit an Expansion Application available on the <u>Small Business</u> <u>Certification and Contract Management System</u> with applicable supporting documentation.

Important Information for Maintaining Your Certification

The anniversary date of your firm's DBE certification is **October 31, 2025.** It is your responsibility to annually submit the required No Change Affidavit and applicable supporting documentation by completing the Annual No Change Application in the <u>Small Business Certification and Contract Management System.</u>

Every third anniversary requires submittal of the 3-year Review Application. The three-year anniversary of your firm's certification is **October 31, 2025.** Pursuant to 49 CFR 26.83(i), submittal of this information is required to ensure that there is no interruption of your firm's status as a certified DBE.

Finally, you must inform DSBO, in writing, of any changes that occur in the firm's legal structure, ownership, management, or control, within thirty (30) days of such change. Notifications regarding changes must be submitted to certificationinfo@denvergov.org. Please follow-up to ensure your notification was received. Failure to report any of these changes may result in removal of your firm's certification eligibility and listing in the certification directory.

FAILURE TO SUBMIT THE ANNUAL UPDATE AND REQUIRED DOCUMENTATION, OR TO REPORT ANY CHANGES MAY RESULT IN SUSPENSION AND/OR REVOCATION OF YOUR CERTIFICATION AND REMOVAL OF YOUR FIRM FROM THE ONLINE DIRECTORY
